A site investigation will be conducted pursuant to COGCC rule 911 at the MARICK-611N61W 29NENE (306276) oil and gas location pertaining to the cut/cap of the Marick 1-29 wellhead (05-123-24342) and abandonment of the Marick 1-29 flowline 12324342FL (470791) approximately 1590-ft. Grab confirmation soil samples will be collected from beneath the wellhead and flowline start/end points. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
