COGCC Inspection Report Summary
On Thursday 6/23/2022 at approximately 1100, I, Inspector Scott Ramsey, conducted a follow up inspection at TEP Weinreis A, at Location # 335548 in Garfield county Colorado.
Any Corrective Actions from previous Inspections that have not been addressed are still applicable.
While there, I observed normal production operations. All meters have been calibrated on location within the past year. This location is within or in close proximity to a CPW Density/High Priority Habitat, black bear, NSO habitat, Wildlife Management. Operator (TERRA) has provided there Piceance Basin Storm water Manual of BMP's (SC-4) for a tracking pad.
During this inspection the following possible compliance issues were observed:
1. Random staining.
2. Random debris.
3. Cut slope shows signs of erosion and lack of stabilization.
4. One valve on a tank is actively leaking. I attempted to contact operator (Justin Mahaffee) left a message about this.

A follow up on this site inspection will be conducted to ensure the compliance issues have been corrected to comply with COGCC rules.
