Basis for Review: Operator does not own or operate the location

Operator Comment: Aerial imagery from COGCC website shows this surface disturbance occurred between 2013 and 2015. Oxy has no records of any oil and gas facilities at this location. COGCC's GIS data does not show any former or current oil and gas facility at the location. It is Oxy's understanding that this surface disturbance was created by the surface owner for their private use, and is unrelated to any oil and gas activities.

COGCC Decision: **Not Approved**

COGCC Representative: COGCC staff has prior knowledge of oil and gas disturbance that occurred from Drill Site 3 to the associated facility at CR 562. There has been previous inspections citing this associated facility and previous Corrective Action was performed by OXY at the associated facility.
