Comment

The previous inspection noted the establishment of cheatgrass (List C Noxious weed) which is not observed in reference areas. It does not appear the Operator has performed further reclamation activities or conducted any cheatgrass management due to the higher abundance of cheatgrass observed throughout interim reclamation areas. Additional concerns are that cheatgrass will migrate off interim reclamation areas and start to propagate onto reference areas.

Interim reclamation areas do have some desirable vegetative growth but additional reclamation activities will also need to be performed because cheatgrass establishment is degrading interim reclamation vegetation success.

Corrective Action

Operator shall submit an interim reclamation plan and cheatgrass management plan via a Form 4 Sundry Notice no later than July 28, 2022. The plan shall focus on preventing cheatgrass seed production and depleting seed bank reserves and it shall detail the additional interim reclamation procedures that will be performed to meet Rule 1003 vegetative standards.
