A site investigation will be conducted pursuant to COGCC rule 911 at the BARCLAY CRISMAN-63N66W (405923) oil and gas location pertaining to the removal of the equipment associated with the Barclay Crisman 2-8-20 (05-123-24110): separator, oil tank, water vault.

Proposed Soil Sampling

Grab confirmation soil samples will be collected from beneath the separator, oil tank, and water vault. A grab confirmation soil sample will be collected from beneath the produced water vault as well as from the side wall that indicated the highest field screening levels. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
