It was observed in this inspection that the Location has been constructed, and surface equipment (pipe/riser) was observed installed along the access road, however no wells have been drilled.

Work to maintain the Location and access road has not occurred.

All Form 2 and Federal "permits to drill" on file for the Location have expired; Form 2 #400473417 expired 4/10/2016, Federal Permit (doc. no 1828332) expired 7/31/2010.

Location is subject to Final Reclamation requirements. Submission of additional permits does not waive compliance with 1004 requirements- See "Notice to Operators: Interim Reclamation Procedures for Delayed Operations" dated January 5, 2017.

Comment: It was observed in this inspection that Stormwater and erosion control BMPs to control stormwater in a manner that minimizes erosion and degradation are missing or insufficient on the Location; erosion degradation due to runoff resulting in large soil movement and gully erosion on the slopes observed.

Corrective Action: **Comply with 1002.f and install stormwater and erosion control BMPs on the Location to manage stormwater in a manner that minimizes erosion and degradation. Install BMPs in accordance with good engineering practices, and maintain until the site receives a passing final inspection.**
