	<p>The well location does not comply with 1004 rule. Limited plant growth of desirable species was observed and recontouring/regrading issues observed at well location.</p> <p>The tank battery does not comply with 1004 rule. Operator has performed final reclamation activities, with the evidence of drill rows and straw crimped mulch. However germination of desirable species was not observed during the inspection and area is dominated by an annual weedy vegetation, Kochia.</p>	
Corrective Action:	<p>Comply with Rule 1004. Reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management.</p> <p>The corrective date is not intended to be the date for which the Operator shall complete the corrective actions but rather the corrective date is the date the location was observed out of compliance.</p>	Date 05/26/2022
