The COGCC Orphan Well Program will be plugging the Canfield (OWP) #1 well and decommissioning any associated on location flow lines and/or production equipment. Soil samples will be collected in accordance with COGCC Rule 915.e(2)B. Samples will be collected from the wellhead excavation, flow line path(s), as well as any other area likely to have been impacted. Samples will be submitted for laboratory analysis of Table 915-1 constituents.

Soil samples will be collected for laboratory analysis of Table 915-1 constituents from areas most likely to have been impacted. Based on these observations, soil samples may be collected and submitted for laboratory analysis of Table 915-1 constituents. Discrete soil samples will be collected for confirmation of compliance with Table 915-1.

Environmental	COGCC Inspection Record documents that the well has been discharging water and gas to the surface dating back to 7/25/2018 (doc #692400030). Given the likely presence of shallow groundwater, likelihood of seasonal variability in depth to groundwater, and documented threats to both groundwater and surface water from water discharge, this project is subject to Table 915-1 Protection of Groundwater SSLs.
