One soil sample was collected immediately beneath the heater treater with is connected to the manway of the tank battery. The soil was screened and sampled to determine if hydrocarbon impacts were present. Investigative actions were directed by field personnel who characterized the soil using olfactory observations and field screened the soil for volatile organic compounds using a photoionization detector (PID). The attached report of work completed (ROWC) details the initial and final release characterization associated with the manway tank battery release.

Describe how remediation of existing impacts to soil and groundwater is to be accomplished (i.e. summarize remedial action plan). Remediation is not warranted as impacts were not identified during the point of release characterization sampling activities beneath the failed manway. As described in the attached Report of Work Completed (ROWC), at no time during sampling and screening activities was groundwater intercepted or observed. Therefore, the site should be assessed under the COGCC Table 915-1 Residential Soil Screening Level Concentrations (RSSLC) and not the more stringent COGCC Table 915-1 Protection of Groundwater Soil Screening Level Concentrations (PGSSLC). Other studies at this location have confirmed there is not a defined path to groundwater at this site. The negligible RSSLC inorganic exceedances documented at the site, specifically SAR and PH, should be evaluated and considered as naturally occurring as the elevated values observed are within the range of the adjacent undisturbed lands not related to the release or general production operations as described in the attached ROWC. Additionally, the documented RSSLC exceedance of arsenic should be considered as naturally occurring and was found to be less than the concentration of arsenic observed in the regional background soil samples. The release assessment and background soil sampling analytical results are summarized in attached ROWC.
