OPERATOR COMMENT AND SUBMITTAL

Comment: To fulfill the corrective actions stated in the Form 4 conducted by Aaron Trujillo on June 14th, 2022 (document number 696203756) Utah Gas Corp removed the fence and pipeline risers to receive approval of final reclamation at the Douglas Pass Unit 7713. The pipeline risers on location were cut and capped below surface according to current regulations. The fence was removed from this location at that time. Any soil disturbances were broadcast seeded with a native/weed-free seed mix immediately following the removal of the surface equipment.
