Inspection #696203619 observed areas on the soil stockpiles that were not progressing towards reclamation standards; vegetation predominantly a cheatgrass monoculture. Inspection require Operator to conduct additional reclamation, and to implement BMPs at stockpiled soils to prevent weed establishment.
