Comments The nearest well in unit per 2-D calculation is the Ruby East 5 @ 440'.  
 The nearest outside operated well per 2-D calculation is the Elder 2X-HNB-09-07-65 (API: 05-123-50239) AP Status @ 931'.  
 Bayswater plans to move a spudder rig to location as soon as the Form 2s are approved to expedite the drilling of the Ruby 7-J pad wells. Due to the schedule completion of the directly offset Topaz 6-l pad, the window to drill the Ruby wells without interference is small and would drastically delay the production if missed. We respectfully request that this Form be processed as quickly as possible to meet this operational timeline.

The horizontal portion of every well will be logged with a measured-while-drilling gamma-ray log. The Form 5, Completion Report, for each well on the pad will list all logs run and have those logs attached. The Form 5 for a well without open-hole logs shall clearly state "Alternative Logging Program - No open-hole logs were run" and shall clearly identify (by API#, well name & number) the well in which open-hole logs were run.
