It was observed in this inspection that reclamation of areas not needed for production has been conducted. CA has been addressed.

Location is currently in its second growing season since work was required (4/30/2021). It was observed in this inspection that desirable plant germination and establishment is not occurring throughout the majority of the interim areas, and Location is not progressing towards COGCC 1003 uniform desirable vegetative establishment.

Additional revegetation work required.

Comply with 1003 rules and conduct additional reclamation work. Continue to monitor and manage interim areas to ensure site progressing towards 1003 reclamation standards.
