INITIAL ACTION SUMMARY

A site investigation will be conducted pursuant to COGCC rule 911 at the Marick 1,7, 10-29 Tank Battery (468102) oil and gas location pertaining to the decommission of production facilities and abandonment of on-location flowlines. See site map exhibit for details.

Grab confirmation soil samples will be collected from beneath the above ground oil tank, water vaults, separator, and ECD KO Tank. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
