A monitoring well (DWR Receipt # 3661337, Permit # 292287) is approx. 1300-ft to the N. This well was constructed to 1406-ft with a static water level of 165-ft. A monitoring well (DWR Receipt # 3659429, Permit # 290984) is approx. 1330-ft N. This well was constructed to 1418-ft with a static water level of 145-ft.

Groundwater less than 20 ft is not expected at the disturbance location.

This location is within ¼ mile of a HPH Pronghorn Winter Concentration Area.

This flowline, approximately 1950-ft, will be removed. See site map exhibit for details.

Grab confirmation soil samples will be collected from wellhead and flowline start/end points. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
