COMMENTS:

The purpose of this Form 4 is to sundry the previously submitted Form 27 – Groundwater Monitoring, Sampling, and Analysis Plan for the GV 25-27 well pad location (document #1733767).

The approved Form 27 described investigation activities proposed to confirm that groundwater standards at this site are below the COGCC Table 910-1 requirements.

On May 16, 2014, impacted soil was discovered when the SPCC containment structure was being upgraded to a steel lined SPCC containment ring. The area impacted by the historical release was excavated to a depth of approximately 7 feet bgs where groundwater was encountered. A surface water sample collected from the bottom of the excavation met the COGCC 910-1 standards for BTEX in groundwater (the analytical data was included in the Form 27 submittal). The overall goal of the groundwater monitoring proposed in the Form 27 was to confirm that groundwater standards at this site are below the COGCC Table 910-1 requirements. In the Form 27, WPX proposed to install five two-inch monitoring wells (1 upgradient and 4 downgradient). WPX's contractors were able to install only one downgradient well (MW2-see attached map). The remaining wells were not installed due to the presence of very densely packed river cobble with very little fines in this area. Conventional drilling rigs were unable to advance wellbores to groundwater.

As an alternative, WPX proposes to excavate one test hole (MW1 – see attached map) in addition to the monitoring well. The test hole would be excavated to a depth of 10' bgs and a two inch perforated PVC pipe will be installed to that depth; the pipe will be screened from 5' bgs to TD.

Both wells will be sampled following procedures described in the approved Form 27.
