



WELL SUMMARY

The Berenergy, UPRR Linnebur #1-11, in the NESW corner of Section 11-3S-60W, Adams County, Colorado, was drilled to a total depth of 6450', October 31, 1981.

The primary objectives were the "D" & "J" Sands, found at depths of 6257' (-1272') and 6328' (-1343') respectively.

The "D" Sandstone showed poor porosities - 10%, 100% water saturation and no oil stain.

The "J" Sandstone showed light oil stain and faint residual fluorescence, porosities 10%-15% and 91-100% water saturation.

A decision was made to plug and abandon the well October 31, 1981.
