Comment:

COGCC Staff observed flood irrigation operations on July 16 and 17. After collecting drone and handheld Trimble data, COGCC Staff identified an area along the western location that appears to be too high and not allowing for successful flood irrigation to a northern section. Refer to the attached inspection photos.

COGCC Staff will be issuing a future corrective action date in the Fall of 2022. Before a corrective action date is issued, the Operator would like to observe the next flood irrigation operation with COGCC Staff, which will likely be sometime in August.

COGCC Staff contacted Operator representatives on July 27, 2022 to discuss the observations, schedule a future follow up, and corrective actions.
