**Procedure Description:** Per COGCC inspection No. 696203698 corrective actions, Laramie plans to reclaim that portion of access road to the abandoned Fed 1-3 well pad commencing October 1, 2022. The road will be reclaimed in accordance with those requirements the BLM attached to the COA's for the spur road to the Federal 1-3. The road will be ripped scarified reshaped to match the surrounding topography as reasonably possible. The access will be made impassable to vehicles and off road vehicles. The recommended BLM seed mix for the elevation and area will be used. See attached exhibit of that portion of the access road to be reclaimed.
