<p><b>Final Reclamation Comments</b></p> <p>Operator submitted Notice of Intent to Abandon #402951920. Per 1004 Rules, reclamation work shall be completed within twelve (12) months on non-crop land after plugging a well or final closure of associated production facilities. Final Reclamation includes but is not limited to gravel removal, compaction alleviation (cross ripping to a minimum depth of 18 inches), recontouring/regrading, replacement of topsoil, and revegetation activities on the Location and access road. Use a seed mixture provided by the surface owner, or a mixture prescribed by the local soil conservation district.</p> <p>It was observed in this inspection that the Location was previously seeded with the non-native species crested wheatgrass, which is not found in reference areas. Per 1004 Rules vegetative cover should reflect reference area forbs, shrubs and grasses and the Operator must use a seed mixture provided by the surface owner, or a mixture prescribed by the local soil conservation district.</p>	omalleya	07/28/2022
