INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

On March 8, 2021, approximately 206 tons of impacted soil were disposed of at the Front Range Landfill. Post-excavation confirmation soil samples collected on March 9, 2021, show that all organic constituents were below the applicable COGCC Table 915-1 Protection of Groundwater Soil Screening Level Concentrations. Groundwater wells were subsequently installed and benzene, 1,3,5-trimethylbenzene, and/or sulfate concentrations in 2 samples collected on August 6, 2021, exceeded the applicable COGCC Table 915-1 Groundwater Cleanup Concentration. In addition, light, non-aqueous phase liquid was detected on the groundwater surface in two wells. Analytical results and sample location figures are attached.

PROPOSED SAMPLING PLAN

Proposed Soil Sampling

Will soil samples be collected as part of this investigation? (Number, type (grab/composite), analyses, and locations of samples):

Companion soil borings MW-1 through MW-4 will be installed adjacent to existing wells MW-1 through MW-4. In addition, soil borings SB-1 through SB-4 will be installed to approximately 15 feet below land surface (bls) at the locations shown on the attached proposed assessment location map. Background soil borings BK-1 through BK-4 will be installed to approximately 15 feet bls. Soil samples will be collected at 2-foot intervals and field screened with a photoionization detector (PID). Based on PID field screening, a minimum of one soil sample will be submitted for the contaminants of concern listed in COGCC Table 915-1. Additional soil borings and/or samples may be collected to fully assess the horizontal and vertical extent of soil impacts.

Proposed Groundwater Sampling

Will groundwater samples be collected as part of this investigation? (Number, analyses, and locations of samples):

Existing wells MW-1 through MW-4 will be sampled. If groundwater is observed in proposed soil borings SB-1 through SB-4, temporary monitoring wells will be constructed and samples collected from the wells. Groundwater samples will be analyzed for the organic and inorganic compounds in groundwater listed in COGCC Table 915-1.
