This initial Form 27 is submitted for the plugging and abandonment (PA) of the Petroshare Corp. - Running Creek (OWP) #11-21 well, flowline abandonment, and remote tank battery. The Running Creek (OWP) #11-21 is in the Orphaned Well Program. Soil samples will be collected from the wellhead, flowline ends, and areas of the tank battery to assess potential exploration and production (E&P) Waste Impacts.

Grab soil samples will be collected from the wellhead excavation, ends of flowlines, and areas at the Tank Battery where E&P Waste impacts are most likely. The soil samples will be submitted for laboratory analysis of Table 915-1 soil parameters.
