On 08/03/2022, Inspector O'Malley spoke with Russ Snowden, of SWN. Mr. Snowden informed Inspector O'Malley that it had rained hard that week and the cement washout had been washed away by rain. This is an unacceptable method of "removal" of a stormwater pollutant. Operator has not provided evidence that cement washout was properly removed from the Location.

The photo referred to in this FIRR showed cement washout covering vegetation and the soil surface, which was present next to the pile of limestone rock.
