Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the DALE 01 wellhead cut and cap and flowline removal. Approximately 650' of flowline was removed. The wellhead was cut and capped per COGCC rules.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. One (1) grab confirmation soil sample was collected at the wellhead excavation ad flowline terminus. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
