Grab confirmation soil samples will be collected from beneath the above ground oil tank, water vault, separator, and wellhead. A grab confirmation soil sample will be collected from beneath the produced water vault as well as from the side wall that indicated the highest field screening levels. Soil samples will be analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. All samples collected will be analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

Reclamation Specialist	Soil sample analytical results indicate pH and SAR exceeds the allowable level for Table 915-1 soil suitability for reclamation at a depth ranging from four-six feet bgs. The extent is limited and below the plant root zone; therefore, the limited area and depth of pH and SAR should not negatively affect plant growth. No further action is necessary at this time. However, should future conditions at the site indicate poor growth that is not reflective of reference areas, then further investigation and reclamation activities may be required.	08/08/2022
Environmental	Based on the information presented no further remedial action is necessary at this time and the COGCC approves the closure request. However, should future conditions at the site indicate contaminant concentrations in soils exceeding COGCC standards or if groundwater is found to be impacted, then further investigation and/or remediation activities may be required. The surface area disturbed by the remediation activity shall be reclaimed in accordance with the 1000 Series Reclamation Rules.
