Locin Oil Corporation requests approval of alternative MIT for the FEDERAL 06-03 as allowed for by Rule 417.b.(3) after Director consideration of any equivalent test or combination of tests.

Locin believes the FEDERAL 27-16 demonstrates mechanical integrity based on the attached bradenhead test performed 5/17/2022 showing acceptable bradenhead pressure and tubing/casing pressure. Well pressures including the bradenhead are monitored to ensure integrity.

This well was SI as a result of the Baxter Pass Gas Processing Plant shut down and was producing at the time of this facility shut down and would otherwise still be producing.

Operator Comments:

The Carbonera (Baxter Pass) Gas Processing Plant was shut down after a major equipment failure and the decision was made not to make the costly repair at that time. Due to the facility shut down, the entire field had zero takeaway capacity. Because of this stranded gas, Utah Gas Corp acquired the Baxter Pass Gas Processing Plant with the intent to perform necessary repairs and have the facility up and running before the end of the first quarter of 2022. Lengthy delays in getting parts for the repairs has prolonged commissioning and start-up of the facility. This Form 4 is being filed for the FEDERAL 27-16 in response to these delays and the need for an alternative MIT approval to satisfy timing requirements per COGCC Rule 417.b.
