Description of Alleged Violation:

Pursuant to Rule 603.f., Overland Resources LLC ("Operator") shall keep free of the following at all locations, including wells and surface production facilities: equipment, vehicles, and supplies not necessary for use on that lease; weeds; rubbish, and other waste material.

On 10/12/2018 COGCC staff performed an inspection of Overland Resources LLC's Handke 1 lease and noted uncontrolled weeds around wellhead in document #688400413.

On 03/12/2019 COGCC staff performed a followup inspection of Overland Resources LLC's Handke 1 lease and noted CAs not completed in document #688401491.

On 04/25/2019 COGCC staff performed a followup inspection of Overland Resources LLC's Handke 1 lease and noted CAs not completed in document #685100832.

Operator failed to keep the location free of unused equipment and weeds, violating Rule 603.f.
