OPERATOR COMMENT AND SUBMITTAL

Comment: All monitoring wells were abandoned per the Division of Natural Resources database. This was confirmed by a telephone call to Marcom LLC. A table showing the abandonment information is attached. Field staff informed me that not all well flush mount concrete/well boxes were removed at the time of abandonment. Prospect removed remaining well boxes (MW-2, 2, 3, 4, 6) on June 18, 2022. Photos of the well areas(now reclaimed to road base) are attached.

Documentation related to the spill discovered on 5/9/2022 is provided in the Spill Report, Form 19, Initial document is 403049822.
