Comment: COGCC Environmental Inspection of Land Application and Remediation Project 15605 in response to Remediation closure request. Closure is not approved at this time. Operator has not demonstrated that arsenic concentrations in soil comply with either Table 915-1 or background levels. Some evidence of seeding was present at a August 5, 2022 site inspection. However little to no desirable vegetative growth is present.

Corrective Action: Operator shall submit a Form 27 Supplemental with a revised Remediation Plan and a detailed reclamation plan with in 60 days (by October 15, 2022).
