DETAILS OF WORK

SPUDED: 6:00 P.M. 3-6-59. Drilled 112' of 12-1/4" hole.

CASING: Ran 3 Jts. of 8-5/8" drill pipe. Total pipe run was 98.09'; set at 112.09' KB w/100 sx of regular 3% CaCl Cement. Plug down @ 12:30 A.M. 3-7-59.

ELEVATION: 5029.3 GL - 5041.3 KB WELL RESULTS: D&A

CORING: Christensen corehead -- Cored 6443 - 6459'; barrel jammed 16' in 6 Hrs. Rec 13-1/2': 1' sd, grey, reworked, tite, fine grain, hard, many black sh laminae; 1/2' sh, black, hard, fissile; 1' sd, grey, very fine grain, hard, tite, poor P&P, black sh laminae, no shows; 2' sd grey, very fine grain, hard, tite w/vert fractures, poor P&P, no shows; 1' sh, black, hard, fissile w/fine grey sd stringers & lenses--no shows; 4' alternate sd & sh, laminae--no shows; 2' sh, black, hard, coarse, grey sd lenses--no shows; 2' sh, black, hard, highly frac. Sample top of the 'D' 6439; 'J' 6484 from 6505 to 6510'. Very few clusters of sd w/possible staining, but the staining due probably from residual oil of some kind.

LOG TOPS: Niobrara 5622; Ft. Hays 6000; Carlile 6041; Green Horn 6113; Bentonite 6344; 'D' 6441; 'J' 6496; Schlumberger TD 6562; Driller's TD 6555'.

PLUGGING: Verbal permission to plug obtained from Mr. Rogers 3-12-59, using 10 sx plug at bottom of surface pipe and 5 sx plug at top. Plugged 3-13-59 in accordance with Mr. Rogers' instructions.
