Comment Previous inspection #702800412 observed Russian knapweed at the northeast and southwest of the Location. Inspector required Operator to conduct weed management by 7/13/2022. Operator submitted resolution #403143516 stating weeds were treated.

It was observed in this inspection that the patches of knapweed observed in inspection #702800412 appear untreated. It is unclear if the multiple patches of Russian knapweed on Location have been treated at this time. A follow up inspection will be conducted in the 2023 growing season to assess the status of the knapweed infestation on this Location. Ongoing weed management is required and the Operator is encouraged utilize the appropriate measures (type and timing) to treat particular weed species.
