Corrective Action: Operator shall submit an interim reclamation plan and cheatgrass management plan via a Form 4 Sundry Notice no later than July 28, 2022. The plan shall focus on preventing cheatgrass seed production and depleting seed bank reserves and it shall detail the additional interim reclamation procedures that will be performed to meet Rule 1003 vegetative standards.

Operator Comment: Cheat Grass Management plan is attached.

CCRP intends to use entire location for drilling and completion operations for the Sumac 1265-13 wells, including above ground storage for frac water. The Sumac wells are in Section 13, Township 12 North, Range 65. Reference exhibit C sections 9 and 10 on page 3 of the OGD (Spacing Application, docket 220600____) where CCRP committed that the Grynberg location will be abandoned and reclaimed after Sumac DSU development. CCRP also outlined these intentions in the permit application documents (currently in draft for COGCC requested fixes), including on page 3 of the "Weld County consultation" using the Grynberg to stage water, and on Page 1 of the "ALA Summary" using location for other operations. As such, CCRP does not intend to interim reclaim the location, but will final reclaim the location after Sumac drilling is completed.

COGCC Decision: Approved pending re-inspection

COGCC Representative: Approved pending re-inspection of this FIR resolution acknowledges the document was received. It is not an acknowledgement that the corrective action has been passed. A field inspection will be conducted at a future date to evaluate compliance with COGCC standards and to evaluate the effectiveness of proposed cheatgrass management plan.
