Species include bull thistle, Canada thistle, houndstongue (List B Noxious), cheatgrass (List C Noxious), alyssum, bur buttercup, tall tumbled mustard, field brome and prostrate knotweed (annual undesirable plant species/weeds).

	<p style="color: blue;">Refer to the "Location section" of this inspection report for weed control corrective action.</p> <p style="color: blue;">It was observed in this inspection that Final Reclamation has not been performed. The Location remains; no recontouring has been performed, cut and fill slopes remain, the pad and road surface are flat, compacted and graveled. Per document #402706440 well PA 5/27/21. Per 1004 Rules Final Reclamation was required to be completed by 5/27/22. This date is being given as the corrective action date. Note, reclamation must be performed on the road and working pad as well as on areas adjacent to the working pad which were previously disturbed during construction. These areas have not been properly reclaimed and are a monoculture of cheatgrass.</p>	
Corrective Action:	<p>Conduct Final Reclamation in accordance with 1004 Rules. Final Reclamation includes but is not limited to gravel removal, compaction alleviation (cross ripping to a minimum depth of 18 inches), recontouring/regrading, replacement of topsoil, and revegetation activities on the Location and access road. Use a seed mixture provided by the surface owner, or a mixture prescribed by the local soil conservation district.</p>	Date 05/27/2022
