The access road was left and the well pad was not recontoured, per surface owner request, all areas of the well pad disturbance were seeded in 2008 and reseeded in 2018, and have been revegetated to greater than 80% of reference areas per the attached third-party quantitative vegetation assessment. Through continued monitoring and third-party vegetation assessments, Caerus has determined final reclamation of this location is complete per Rule 1004.c. Please see the attached third-party quantitative vegetation assessment showing the vegetative cover of reclaimed portions of the disturbance reflect nearby reference areas with similar slope, aspect, elevation, and land use and have achieved Rule 1004.c.(2) cover standards. The Surface Owner's final reclamation variance request was submitted on 5/27/2020 and approved on 11/30/2020 (Doc #402378934). The surface owner's designated final land use has changed and the site is now used for livestock holding and as a camp area for ranching operations. This is hindering vegetation establishment but the site reflects reference areas on the property with similar land use. Based on Caerus and contractor inspections, the site meets Rule 1004.c., 1004.e., and all associated Conditions of Approval relating to the variance: Greater than 80% reference area vegetation cover has been established on reclaimed portions of the site. The site and road are stabilized in such a way as to minimize erosion to the extent practicable. Weeds are treated each year and the site is as free as practicable, based on the land use, of all undesirable plant species designated to be noxious weeds. Caerus respectfully requests the COGCC perform a final reclamation inspection during this growing season.
