COGCC Representative: Operator response of "Corrective Action Completed" is a notification to the State that the corrective action has been addressed in its entirety. Based on operator comments corrective action does not appear to have been completed.

Inspection #702800465 dated 7/19/22 observed that corrective action to comply with Rule 606 in regards to the access road being overgrown with weeds had been addressed. Inspector also observed "annual and noxious weeds are present on Location. A path around the Location has been mowed, however, annual and noxious weeds remain throughout the Location, including directly adjacent to production equipment." Operator was required to comply with Rule 606. Based on Operator comment, the corrective action to address vegetation throughout the Location including around production equipment has not been addressed.
