Corrective Action:	<p>Refer to the "Location" section of this inspection report for weed control corrective action.</p> <p>This location does not meet reclamation requirements; insufficient vegetative cover. Bare ground and annual weeds dominate the Location. Russian thistle, tumbling saltweed, alyssum (annual undesirable plant species/introduced weeds) are common. Cheatgrass (List C Noxious) is occasional. Perennial grasses (western wheatgrass) are sparse. Successful seed rows are occasionally evident, while large areas with no seeded species are also present.</p> <p>Vegetative cover on the access road is also insufficient. Bare ground, Russian thistle and cheatgrass dominate the access road. Perennial grasses are occasionally present.</p> <p>Comply with 1004 Rules. Conduct additional reclamation in accordance with COGCC 1000 series rules on the Location and access road. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of pre-disturbance or reference area levels. Use a seed mixture requested by the surface owner, or a mixture prescribed by the local soil conservation district. Ensure erosion controls are implemented to stabilize the seeded soil, and continue to monitor and manage this site until Final Reclamation has passed.
