### INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

A contractor for Extraction was boring a new line under KPK's consolidation flowline (currently shut-in due to line being stung East of release) and an abandoned flowline, when they encountered a historical release via drill cuttings and tie-in access. There are no live lines in the area and the only active line was flushed before this release was discovered. Following the completion of soil sample collection extraction had completed temporary backfill at this location.

### PROPOSED SAMPLING PLAN

Confirmation samples were collected by Extraction Oil and Gas and submitted run for COGCC table 910 analytes. Following this extraction completed repairs on there line and backfilled the excavation without clean confirmation samples. The source has been removed but impacts remain in-situ. On behalf of KPK, MarCom is proposing delineation boring to determine where impacts remain and the extent of the excavation. COGCC will be notified 48 hours prior to conducting borings for delineation with the Geoprobe. Borings will begin inside the excavation area to determine if impacts remain. The proposed delineation borings will then be conducted if impacts are remaining to determine the extent of the impacts. All of this can be found on the attached proposed boring map.
