INITIAL ACTION SUMMARY

Description of initial action or emergency response measures taken to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the BECCA D03-11 wellhead cut and cap and flowline abandonment. Approximately 555' of flowline was abandoned-in-place. Approximately 860' of flowline was removed. The wellhead was cut and capped per COGCC rules.

A grab soil sample will be collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. One grab confirmation soil sample will be collected at the wellhead excavation, and one sample collected from the flowline terminus. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron. One sample was collected for waste characterization of metals. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

A site assessment will be scheduled to delineate impacted media identified at WH-FS-01@7'. Chevron proposes soil samples will be collected for analysis of TPH (C6-C36) and Table 915-1 organics in soil. Soil sample location FL-SS-01@4' will be assessed and soil samples will be collected for boron analysis. If groundwater is encountered during the wellhead assessment, each soil boring will be completed as a monitoring well and the groundwater will be sampled for BTEX, naphthalene, 1,2,4-trimethylbenzene, 1,3,5-trimethylbenzene, 1-methylnaphthalene, and inorganic parameters.
