Comment Per the previous FIR, the Operator submitted a reclamation plan on February 1, 2022 (Doc.# 402943865). COGCC Staff reviewed the plan and put it back into draft with seven (7) conditions of approval (COA). Operator resubmitted the plan on May 25, 2022 (Doc.# 403059177) and sufficiently addressed the COA's.

This inspection was to document the scope of reclamation work since cleanup efforts are complete. COGCC Staff met with a KPK Contractor and walked the entire project west of CR 23. Native wetland vegetation has established throughout the ditch since the ditch was excavated during the cleanup. Refer to the attached inspection photos.

Reclamation work identified in Photos 1-3 is planned to commence the week of September 12th.
