Reclamation Comments: This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland. Well was plugged 11/18/2019. Previous inspection document #693600212 on 03/19/2020 stated reclamation work had not commenced at the time of inspection. It does not appear any reclamation work has been performed since last inspection; gravel remains throughout the location and access roads which have not been re-contoured or re-graded; weedy, annual vegetation was observed which includes but not limited to russian thistle, kochia, and field bindweed (CO List C Noxious Weed). Equipment including tank batteries, pipe/rods, telemetry equipment, chemical tanks, wires, and debris were observed on location. Oil stained dirt was also observed around the tank batteries that did not have manhole coverings. Refer to attached inspection photos.	edwardsond	09/16/2022
Corrective Actions: Comply with Rule 1004. Operator shall remove all oil and gas related equipment; perform decompaction of soils by cross ripping to a depth of 18" to prepare seed bed; remove oily soils and test location soils for Table 915-1 exceedences; reseed disturbance areas using a seed mixture requested by the surface owner, or a mixture prescribed by the local county NRCS. Establish vegetation with total perennial, non-invasive uniform plant cover of at least eighty (80) percent of reference area levels. Ensure erosion controls are implemented to stabilize the seeded soil. Operator shall continue to monitor and manage this site until the location meets Rule 1004 standards, including stormwater and weed management. Submit soil analytical results in FIR Resolution form. Final reclamation activities shall be complete no later than 11/15/2022.	edwardsond	09/16/2022
