It was observed in this inspection that though the overall reclamation status for the Location is "in process", however there are bare areas within the central area of the site, and along the access road where uniform desirable vegetative establishment/germination is not occurring. Noxious weeds also observed (see "Good Housekeeping")

Additional reclamation efforts required within areas not progressing towards 1004 uniform revegetative standards.
