Comment:

This location does not comply with Rule 1004. Reclamation rules require reclamation activities to be conducted within twelve months of plugging on non-cropland; well was plugged 03/28/2019. It does not appear any reclamation work has been performed since last inspection. During this inspection COGCC Staff observed that perimeter fencing and debris remains throughout location; the access roads and location have not been contoured or regraded, and have not revegetated with desirable species; annual weedy vegetation including but not limited to kochia and russian thistle were observed; and the location has gully erosion that has led to sediment transport off location. Refer to attached inspection photos.

Corrective Action:

Comply with 1004 Rules. Corrective action date is being back dated to when all final reclamation activities should have been completed.

Comment:

The location has gully erosion that appears to have transported sediment offsite, south of the location. Inadequate stormwater and erosion controls (straw wattles) are degraded and/or not installed correctly; erosion and stormwater BMPs need to be implemented to stabilize the location and prevent further offsite degradation. Refer to attached inspection photos.

Corrective Action:

Install or repair required BMPs per Rule 1002.f.(2)C. Corrective action must be performed immediately.
