INITIAL ACTION SUMMARY

Description of initial action or emergency response measures take to abate, investigate, and/or remediate impacts associated with E&P Waste.

Pursuant to COGCC Rule 911 a site investigation was conducted pertaining to the HOWARD A27-05 wellhead cut and cap and flowline decommissioning. Approximately 740' of flowline was abandoned-in-place due to field constraints - Form 44# 403111107. The wellhead was cut and capped per COGCC rules.

A grab soil sample was collected at the base of the excavation or the area showing the highest degree of impact during field screening activities at the wellhead excavation. Two (2) grab confirmation soil samples were collected, one (1) at the wellhead excavation, and one (1) at the flowline terminus. Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons) organic compounds in soil per COGCC Table 915-1, EC, SAR, pH, and boron. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.
