Operator Comments:

Wells shut in due to Anadarko Third Creek line abandonment. CCD(City and County of Denver) worked with Anadarko, now Western Gas for a re-connection plan to turn wels back on. That plan is in place. DIA/CCD is working on a new gas contract to reconnect to the "Legacy" Line as wells as a budget for the reconnection work. The budget has to come from the Airport Revenue Fund and given the state of the aviation industry, the budget is taking longer to put together. Approximately half the wells had MITs this year and the other half will be performed in 2021.
