Following completion of the approved sampling plan (Initial Form 27 #403041240), laboratory results indicated a SAR exceedance from the base sample of the PBV excavation. Three additional soil samples were collected from the base of the PBV excavation that indicated compliance with Table 915-1 standards, which indicates an isolated SAR exceedance at the site.

Source sample analysis indicated that a release of produced water would not increase pH values or Arsenic concentrations at the Site. Caerus proposes to use excavated material as backfill at the site, as well as additional suitable backfill material to return pad surface to working grade.

Caerus believes a pathway to groundwater does not exist based on the following reasons, and requests using Table 915-1 Residential SSL Concentrations for comparison to laboratory analytical data:
1) No apparent historical impacts, SAR exceedance isolated to initial sample location at base
2) Depth to groundwater ~200' based on closest water well data (DWR receipt #9502666A)
3) Nearest surface water ~0.23 miles north
Caerus believes all COAs have been met and requests no further action based on the investigative results indicating no apparent historical impacts.
