Description of Alleged Violation:

Pursuant to Rule 405.e.(2), Williford Resources, LLC ("Operator") will provide the Commission written notice 2 business days in advance for planned operations with a work-over rig on a Form 42, Field Operations Notice – Notice of Move-In and Rig-Up on an Oil and Gas Location.

COGCC staff conducted an inspection of Operator's M & M #2 well (API No. 05-067-06623) on July 13, 2022 (document no. 700300433), and observed a workover rig at the well. Staff reviewed COGCC records and determined advance written notice of work-over operations was not provided and required Operator to retroactively submit a Form 42, as a corrective action.

As of September 26, 2022, Operator has not filed a Form 42.

Operator failed to submit a Form 42, Field Operations Notice, in advance of work-over operations, violating Rule 405.e.(2).

Abatement or Corrective Action Required to be Performed by Operator: _____ Corrective Action Due Date: 09/26/2022

Proper and timely abatement does not preclude the assessment of penalties and an Order Finding Violation.

Operator shall retroactively submit a Form 42.

Operator shall demonstrate how their existing procedures, or document changes to their existing procedures, to ensure all future Form 42, Field Operations Notices, are timely filed.

PENALTY

Penalties for violations alleged in this NOAV will be calculated pursuant to Rule 525, with daily penalties accruing pursuant to Section 34-60-121(1), C.R.S.
