APPLICATION

COMES NOW Great Western Operating Company, LLC (Operator No. 10110) ("Great Western" or "Applicant"), by its attorneys, Jost Energy Law, P.C., and makes this application to the Oil and Gas Conservation Commission of the State of Colorado ("Commission") for an order to pool all interests within an approximate 640-acre drilling and spacing unit, as defined below, for the drilling of the Ivey LC 02-033HC Well (API No. Pending) and the Ivey LC 02-036HC Well (API No. Pending) ("Wells"), for the development and operation of the Codell and Niobrara Formations on the following described lands:

Township 1 South, Range 68 West, 6th P.M.

Section 2: E½

Section 11: E½

640-acres, more or less, Adams County, Colorado.

Hereinafter "Application Lands"

In support thereof, Applicant states and alleges as follows:

1. Applicant is a limited liability company duly authorized to conduct business in the State of Colorado, and is a registered operator in good standing with the Commission.

2. Applicant is an Owner as defined by the Colorado Oil and Gas Conservation Act and Commission Rules and owns leasehold interests or holds the right to operate on the Application Lands.

3. On February 19, 1992, the Commission entered Order No. 407-87 (amended August 20, 1993) which, among other things, established 80-acre drilling and spacing units for the production of oil, gas and associated hydrocarbons from the Codell

and Niobrara Formations, with permitted well locations in accordance with the provisions of Order No. 407-1.

4. On April 27, 1998, the Commission adopted Rule 318A, the Greater Wattenberg Area Special Well Location, Spacing and Unit Designation Rule. The Application Lands are subject to this Rule for the Niobrara Formation.

5. On March 20, 2017, the Commission entered Order No. 407-1902, which established an approximate 640-acre drilling and spacing unit for the Application Lands and authorized the drilling of up to 12 horizontal wells in such unit to the Codell and Niobrara Formations, with the producing interval of the wellbores to be located no closer than 460 feet from the unit boundaries and no closer than 150 feet from the productive interval of any other wellbore located in the unit without exception being granted by the Director of the Commission, and authorizing up to one multi-well pad within the Application Lands, subject to Rule 318A, unless the Director grants an exception.

6. Applicant, pursuant to Commission Rule 530 and/or the provisions of § 34-60-116 (6) and (7), C.R.S. hereby requests an order to pool all interests in the approximate 640-acre drilling and spacing unit established for the Application Lands for the development and operation from the Codell and Niobrara Formations, and subject any non-consenting interests, including parties that fail to fulfill their election through timely payment of joint interest billings, to the cost recovery provisions of §34-60-116(7), C.R.S, for the drilling of the Wells.

7. Applicant requests that the Commission's pooling order be made effective as of the earlier of the date of this Application, or the date that the costs specified in § 34-60-116(7)(b), C.R.S. are first incurred for the drilling of the Wells to the Codell and Niobrara Formations on the Application Lands.

8. Applicant certifies that copies of this Application and Notice of Hearing will be served on all persons owning an interest in the mineral estate of the tracts to be pooled as required by Rule 507, and that at least ninety (90) days prior to the hearing on this matter, each such interest owner not already leased or voluntarily pooled will be offered the opportunity to lease, or to participate in the drilling of the respective Wells, and will be provided with the information required by Rule 530 as applicable.

9. Applicant certifies that, based on its reasonable diligence, as of the date of filing Applicant owns approximately 54% of the mineral interests in the drilling and spacing unit comprising the Application Lands to be pooled by the Application, and therefore the Application complies with the requirements of §34-60-116(6)(b)(I), C.R.S.

10. Applicant further certifies that all unleased mineral interest owners of record have been tendered, no less than ninety (90) days before the hearing, a reasonable lease offer, made in good faith, to lease upon terms no less favorable than those currently prevailing in the area at the time application for the order is made and that such the unleased mineral owners have been furnished in writing the owners' share of the

estimated drilling and completion cost of the Wells, the location and objective depth of the Wells, and the estimated spud date for the Wells or range of time within which spudding is to occur. Further, Applicant certifies that the lease offers included a copy of the Commission's pooling brochure. Therefore, the Application complies with the requirements of § 34-60-116(7)(d)(I), C.R.S.

11. Applicant further certifies that election letters and offers to participate in the Wells were sent to the working interest owners in accordance with the requirements of Rule 530 no later than ninety (90) days prior to hearing on the Application. In addition, the election letters were sent with an Authority for Expenditure, Election Form and a proposed Operating Agreement in accordance with Rule 530. Accordingly, the requirement to make an offer to participate has been met.

12. Upon the expiration of the 60-day election period for all elections to participate and all offers to lease, Applicant will submit sworn testimony under Rule 511 with a request to approve the Application without the necessity of a hearing. This sworn testimony will include representative copies of the offers to lease and to participate evidencing compliance with § 34-60-116, C.R.S. and COGCC Rule 530, in addition to a well plat for each Well, a list of parties that may be subject to the statutory cost recovery penalties of § 34-60-116, C.R.S., and the Authority for Expenditure (AFEs) for the Wells.

13. In order to prevent waste and to protect correlative rights, all interests in the approximate 640-acre drilling and spacing unit established for the Application Lands should be pooled for the orderly development and operation of the Wells in the Codell and Niobrara Formations, including any non-consenting interests therein.

14. The granting of this Application is in accord with the Oil and Gas Conservation Act, found at §§ 34-60-101 et seq., C.R.S., and the Commission Rules.

WHEREFORE, Applicant requests that this matter be set for hearing on September 25-26, 2019 that notice be given as required by law, and that upon such hearing, the Commission enter its order to:

A. Pool all interests, including but not limited to any non-consenting interests and any party failing to fulfill its election through the timely payment of joint interest billings, in the approximate 640-acre drilling and spacing unit established for the Application Lands, as defined below, for the drilling of the Ivey LC 02-033HC Well (API No. Pending) and the Ivey LC 02-036HC Well (API No. Pending) for the development and operation of the Codell and Niobrara Formations:

Township 1 South, Range 68 West, 6th P.M.

Section 2: E½

Section 11: E½

640-acres, more or less, Adams County, Colorado.

B. Provide that the Commission's order pooling all interests in the approximate 640-acre drilling and spacing unit is made effective as of the earlier of the date of this Application, or the date that any of the costs specified in § 34-60-116(7)(b), C.R.S. are first incurred for the drilling of the Wells in the 640-acre drilling and spacing unit to the Codell and Niobrara Formations on the Application Lands.


C. Provide that the interests of any owners with whom the Applicant has been unable to secure a lease or other agreement to participate in the drilling of the Wells, or who fail to fulfill their election, are pooled by operation of statute, pursuant to § 34-60-116(6) and (7), C.R.S. and made subject to the cost recovery provisions thereof with respect to any horizontal well drilled to develop the Codell and Niobrara Formations in the drilling and spacing unit comprising the Application Lands.

D. For such other findings and orders as the Commission may deem proper or advisable in this matter.
