SUNDRY NOTICES AND REPORTS ON WELLS

INSTRUCTIONS

Notice must be given to the Director, and approval obtained in advance of the time when the owner or operator expects to recomplate or abandon a well or to change plans. Within thirty (30) days after recompletion, change of plans, or remedial work, a detailed report of the work done and the results obtained shall be submitted on this form in duplicate for wells on Patented and Federal lands, and in triplicate for wells on State lands. In work that affects only rods, pumps or tubing or other routine work such as, but not limited to, cleaning out to previous total depth, no report is necessary.

(DETAILS OF WORK)

1. Pulled rods and tubing
2. Squeezed perforations @ 5587' - 89' KB w/ 86 sx. type "G" cement and 2/10% HR-4.
3. Drilled out cement plug from 5522' to 5589' KB. Cleaned out to TD 5598' KB.
4. Tested squeeze. No entry after swabbing hole dry.
5. Perforated J-3 sand from 5580' - 83' KB w/4 jets/ft. under 250 gal. 10% NE acid.
6. Sandfraced 5580' - 83' KB w/5000 gal. lease crude, 5000# 20-40 sand, 300# adomite.
7. Cleaned up well and ran rods, tubing, and bottom hole pump.
8. Tested: 1-24-66, 2.64 BOPD, 100 BWPD, no gas, frac oil not recovered.
