This well was drilled during the second rig occupation on the Tollway LC Pad.

Surface was set on the Tollway LC 24-363HNX on 3/15/2020. Activities were suspended on 3/15/2020, prior to reaching TD due to changing rig priorities. Great Western anticipates recommencing drilling in Q1 of 2021 with a large rig and plans to set production casing prior to completing the well in Q2 of 2021.

The TPZ and BHL footages are taken from the APD.

The depths are from the smaller surface rig and will change based on the production rig's KB on the final reports.

No logs were run on this well.
