A site investigation was conducted pursuant to COGCC Rule 911 at the UPV ABBEY T3N-R64W-S1 L01 Tank Battery location.

Thirteen (13) grab confirmation soil samples were collected from the produced water vessel(s) excavation, beneath the ground oil tank(s), and at the separator(s). Soil samples were analyzed by a certified laboratory for TPH (total volatile [C6-C10] and extractable [C10-C36] hydrocarbons), organic compounds in soil per COGCC Table 915-1, and EC, SAR, pH, and boron. Additionally, five (5) soil samples were analyzed by a certified laboratory for metals per COGCC Table 915-1. All samples collected were analyzed by a certified laboratory using approved COGCC laboratory analysis methods.

The COGCC Tank Battery and Produced Water Vessel Closure Checklists was utilized and filled out during the abandonment process. A photolog was submitted on the Subsequent Form 27.

The source was successfully removed from the site through a remedial excavation. Based on the successful removal of soil impacted with compounds at concentrations above COGCC Table 915-1 standards, Noble is requesting a No Further Action (NFA) designation for the site.

A total of approximately 68 cubic yards of impacted material were removed for off-Site disposal at the Buffalo Ridge Waste Management Landfill in Keenesburg, Colorado under signed Noble waste manifests. A total of approximately 68 cubic yards of imported clean fill was used to backfill the excavation. The final remedial excavation extent measured approximately 18 ft. by 17 ft. by 6 ft. bgs.
